HB 2057 **

**Subsequent Referral(s) to Ways and Means

(1:00 pm) Authorizes Department of Education to disburse or expend moneys appropriated or allocated to department based on determination of department of intended purposes of moneys.

HB 2058

(1:00 pm) Excludes from criminal records checks conducted by Department of Education certain persons who have submitted to criminal records checks conducted by Teacher Standards and Practices Commission.

HB 2817

(1:00 pm) Allows student enrolled in program provided by school district or education service district to earn General Educational Development (GED) certificate to participate in interscholastic activities.

HB 3236 **

**Subsequent Referral(s) to Ways and Means

(1:00 pm) Establishes Task Force on Education Pathways.

HB 2697

(1:00 pm) Requires education provider to prohibit use or display of any symbols of hate on school property or in education program.

Public Hearing and Possible Work Session

HB 3183

(1:20 pm) Requires school district to provide information about certain services and placements available for children who are deaf or deafblind or who are hard of hearing and to ensure that representative of Oregon School for the Deaf is present for certain meetings related to individualized education programs or 504 Plans.

HB 2136

(1:45 pm) Clarifies terminology of persons who may be investigated or disciplined by Teacher Standards and Practices Commission.

HB 2962

(2:00 pm) Requires each school district to evaluate instructional needs of students of school district as result of school closures due to COVID-19 and to report summaries of evaluations to Department of Education.

HB 3354

(2:20 pm) Directs Teacher Standards and Practices Commission to adopt standards for educator preparation programs relating to evaluations of teacher candidates.

- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this

reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
