HB 2058

CARRIED OVER FROM THE 3/23/2021 AGENDA: (1:00 pm) Excludes from criminal records checks conducted by Department of Education certain persons who have submitted to criminal records checks conducted by Teacher Standards and Practices Commission.

HB 2590 **

**Subsequent Referral(s) to Ways and Means

(1:05 pm) Establishes Task Force on Student Success for Underrepresented Students in Higher Education.

HB 3012

(1:10 pm) Limits ability of public university to refuse new mandatory incidental fees or process for collecting mandatory incidental fees.

HB 2542

(1:15 pm) Requires each public university and community college to prominently display mandatory fees charged.

HB 2919

(1:20 pm) Requires each public university and community college to prominently display total costs of all required course materials and fees for no less than 75 percent of total courses offered by public university or community college.

(1:25 pm) Allows student enrolled in program provided by school district or education service district to earn General Educational Development (GED) certificate to participate in interscholastic activities.

(1:30 pm) Directs Department of Education to provide moneys for payment of costs of education of students in qualified treatment programs.

HB 2093 **

**Subsequent Referral(s) to Ways and Means

(1:45 pm) Alters eligibility requirements and formula for establishing amount of award for Oregon Opportunity Grant and renewal of grant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
