HB 3354

CARRIED OVER FROM THE 03/30/2021 AGENDA: Directs Teacher Standards and Practices Commission to adopt standards for educator preparation programs relating to evaluations of teacher candidates.

HB 2954

CARRIED OVER FROM THE 03/30/2021 AGENDA: Allows public charter school to implement weighted lottery that favors historically underserved students when number of applications for enrollment exceeds capacity of program, class, grade level or building.

HB 2942 A

CARRIED OVER FROM THE 03/30/2021 AGENDA: Removes certain nonviolent crimes from list of crimes that automatically make person ineligible to hold license or registration issued by Teacher Standards and Practices Commission if person has been convicted of crime.

HB 2135

CARRIED OVER FROM THE 03/30/2021 AGENDA: Prohibits Teacher Standards and Practices Commission from issuing license or registration to person convicted of crime constituting domestic violence.

HB 3169 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 03/30/2021 AGENDA: Allows certain schools to qualify as remote school elementary school or small high school and to receive additional distributions from State School Fund if school qualified as remote small elementary school or small high school for 2019-2020 school year.

HB 2092

Alters scope of duties and data collection requirements for Oregon Youth Employment Program.

HB 2945

Requires school districts to ensure that students for whom out-of-school suspensions or expulsions have been imposed receive specified services during suspensions or expulsions.

HB 2631

Prescribes notification requirements for school district upon receipt of report of act of harassment, intimidation, bullying or cyberbullying.

HB 2093 **

**Subsequent Referral(s) to Ways and Means

Alters eligibility requirements and formula for establishing amount of award for Oregon Opportunity Grant and renewal of grant.

HB 3363 **

**Subsequent Referral(s) to Ways and Means

Establishes Racial Equity and Justice Student Council.

HB 2907 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Higher Education Coordinating Commission for Community College Support Fund for distribution to community colleges and community college service districts.

HB 3255

Directs education employer to provide materials and assistance to eligible employees concerning public service loan forgiveness program.

HB 2537 **

**Subsequent Referral(s) to Ways and Means

Allows school districts to use moneys distributed from Student Investment Account for payment of student fees, costs and instructors of career and technical student organization programs.

HB 2989

Establishes state policy that career and technical education is provided through seamless system that begins at secondary school level and progresses to post-secondary career and technical education institutions, community colleges and apprenticeship programs.
