HB 2501 \*\*

\*\*Subsequent Referral(s) to Revenue

Increases formula weight for students in poverty families for purposes of State School Fund distributions.

HB 2166

Directs Superintendent of Public Instruction to convene advisory group to review equity in education system of state and to report results of review to interim committee of Legislative Assembly related to education.

HB 2378

Directs Higher Education Coordinating Commission to establish competency-based education pilot program.

HB 3165 \*\*

Increases minimum percentage of funding that school districts must provide to public charter schools for students enrolled in kindergarten through grade eight if 50 percent or more of students are from population that is historically underserved.

HB 3336

Directs Department of Education to conduct study on education assessments administered in this state and to report results of study to interim committee of Legislative Assembly related to education.

HB 3337

Directs Department of Education to request waiver of federal academic assessment requirements for 2020-2021 school year.
