SB 75

Permits Higher Education Coordinating Commission to use moneys from Oregon Opportunity Grant program to pay for scholarships for children of public safety officers if other sources of money are insufficient to fully fund scholarships.

SB 77 A

Moves program that funds pilot projects in architecture, construction trades and engineering for high school juniors and seniors from Office of Community Colleges and Workforce Development to Higher Education Coordinating Commission.

SB 230

Authorizes Western Oregon University, Southern Oregon University and Eastern Oregon University to offer professional doctoral degrees.

SB 564 A

Requires Higher Education Coordinating Commission to design question or questions allowing each student to identify whether student is parent or person acting as parent or legal guardian that
