SB 713 A

Prohibits public or private post-secondary institution of education from requiring prospective student to disclose whether prospective student has criminal conviction before institution makes final determination on whether to admit student.

SB 234 A

Directs Higher Education Coordinating Commission to convene stakeholder group to study ways to best serve adults in custody who are recently eligible to receive student grants.

SB 486 A

Modifies requirements of plans of instruction for talented and gifted children.

SB 602

Removes sunset on requirement that students must receive certain information related to statewide summative assessments.

SB 702 B

Directs State Board of Education to review social studies standards.

SB 232 A

Modifies requirements of report on Educators Equity Act that is prepared by state agencies.

SB 54

Updates terminology for Youth Development Council to match changes in federal law.
