HB 2165 \*\*

\*\*Subsequent Referral(s) to Transportation then to Ways and Means (1:05 pm) Requires electric companies to collect amount from all retail electricity consumers, to be expended to support transportation electrification pursuant to plan accepted by Public Utility Commission.

### HB 2180

(1:15 pm) Requires Director of Department of Consumer and Business Services to amend state building code to require that new construction of certain buildings include provisions for electrical service capacity for specified percentage of parking spaces.

(1:20 pm) Modifies definition of "recycled paper checkout bag" to include bags that contain nonwood renewable fiber for purposes of single-use checkout bag prohibition.

#### HB 2475

(1:25 pm) Authorizes Public Utility Commission to consider differential energy burden and other inequities of affordability in rates.

HB 2674

(1:30 pm) Directs Department of Environmental Quality to study impacts of engine emissions on environment and provide results of study in report to interim committees of Legislative Assembly no later than September 15, 2022.
