HB 2266

(8:05am) Directs Oregon Business Development Department to study use of economic development methods for purpose of assisting businesses and to report its findings to interim committees of Legislative Assembly related to business on or before September 15, 2022.

HB 3040

(8:20am) Directs Legislative Revenue Officer to study system development charges and report findings to interim committees related to local government.

HB 2173 **

**Subsequent Referral(s) to Revenue

(8:35am) Provides that lottery revenues dedicated to county economic development purposes may be transferred to Oregon Department of Administrative Services to pay for portion of costs of regional solutions coordinators within Regional Solutions Program.

HB 2218

(8:45am) Directs Department of State Lands to study impact of laws related to wetlands on economic development and to provide results of study in report to interim committees of Legislative Assembly no later than September 15, 2022.

HB 2282

(8:55am) Requires Department of Land Conservation and Development to approve City of Bend's expansion of urban growth boundary, and allows department to approve other land use regulations for city on specified lands, if owner of land possesses development opportunity transferred from Metolius resort site owner and city meets other conditions.

HB 2334

(9:05am) Modifies provisions relating to statement of cost of compliance effect on small businesses required as part of agency rulemaking.

HB 2654

(9:15am) Authorizes electric utility to use or allow for use of electric easement in provision of broadband services.

HB 2701 **

**Subsequent Referral(s) to Housing then to Ways and Means

(9:25am) Establishes Rural System Development Charges Program within Housing and Community Services Department to pay system development charges for rural affordable multifamily housing.

HB 2916 **

**Subsequent Referral(s) to Ways and Means

(9:35am) Establishes Blue-Green Timber Economy Task Force.

HB 3177 **

**Subsequent Referral(s) to Rules

(9:40am) Limits types of restrictions that Governor may impose on certain businesses during state of emergency related to COVID-19 pandemic.

- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
