- HB 3000
(3:30 pm) Directs Oregon Liquor Control Commission to study cannabis.
- HB 3013
(3:40 pm) Directs Oregon Liquor Control Commission to study regulation of cannabis.
- HB 3194 **
**Subsequent Referral(s) to Revenue then to Ways and Means
(3:50 pm) Allows licensee, permittee or certificate holder authorized to import, export, sell, distribute, ship or deliver wine to import, export, sell, distribute, ship or deliver low-proof spirit beverages on same terms.
- HB 3083
(4:00 pm) Provides that specifications for public improvement contracts and contracts for public works must require adherence to current seismic safety standards and seismic rehabilitation standards in constructing, reconstructing or performing major renovation on public building or critical infrastructure that is or will be located in area of state that is susceptible to seismic events.
