(3:50 pm) Allows base pay of attorneys who are employed by public corporation, nonprofit organization, public university or city or county in this state and who perform substantially similar work to be used for comparison of compensation for assistant attorneys general.

SB 307

(4:00 pm) Waives fees for obtaining medical marijuana card for veterans who have total disability rating of at least 50 percent as result of injury or illness incurred or aggravated during active military service, and who received discharge or release under other than dishonorable conditions.
SB 636 A

(4:10 pm) Provides that when state agency is required by statute to mail certain notice to individual, and agency has on file post office box address for individual, agency must mail notice to post office box address if address is individual's last known address on file or address to which individual has requested that notices be sent.
