Public Hearing

HB 2648

(3:15 pm) Allows pharmacist or pharmacy technician to transfer drug containing pseudoephedrine without prescription to person who is at least 18 years of age and presents person's valid government-issued photo identification.

HB 2376

(3:40 pm) Requires health care provider who prescribes opioid to offer prescription for naloxone, or similar drug, and educational material under specified circumstances.

HB 2080 **

(4:00 pm) Establishes Office of Pharmaceutical Purchasing in Oregon Health Authority and specifies duties.

HB 2623

(4:20 pm) Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.
