Public Hearing

HB 2044

(3:15 pm) Allows Department of Consumer and Business Services to access data in All Payer All Claims database by certifying data will only be used to carry out department's duties.

HB 2388

(3:35 pm) Expands health benefit plan coverage of childbirth and pregnancy-related health care expenses.

HB 2673

(4:10 pm) Requires individual and group health insurance policies to reimburse services provided by naturopathic physicians within scope of their practice if services are reimbursed when provided by licensed physicians.

HB 2328

(4:25 pm) Adds further specification to prohibition on discrimination against health care providers by insurers in participation in or coverage under health benefit plan.
