HB 2673

(4:10 pm) Requires individual and group health insurance policies to reimburse services provided by naturopathic physicians within scope of their practice if services are reimbursed when provided by licensed physicians.

HB 2328

(4:25 pm) Adds further specification to prohibition on discrimination against health care providers by insurers in participation in or coverage under health benefit plan.
