HB 2359

(3:55 pm) Requires health care providers to work with health care interpreters from health care interpreter registry operated by Oregon Health Authority to provide interpretation services.

HB 2044

(4:25) Allows Department of Consumer and Business Services to access data in All Payer All Claims database by certifying data will only be used to carry out department's duties.

HB 2517

(4:40) Requires coordinated care organizations to report specified information to Oregon Health Authority regarding requests for prior authorization.
