HB 2981 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Oregon Health Authority to establish and administer program to provide palliative care services and support provision of home- and community-based end of life care.

HB 2359

Requires health care providers to work with health care interpreters from health care interpreter registry operated by Oregon Health Authority to provide interpretation services.

Allows Department of Consumer and Business Services to access data in All Payer All Claims database by certifying data will only be used to carry out department's duties.

HB 2528

(3:45 pm) Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.

(4:15 pm) Allows mobile school-based health centers to qualify for safety net grants from Oregon Health Authority.

HB 2464

(4:35 pm) Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program.
