HB 2462

Requires pharmacy benefit manager to amend contract with pharmacy or pharmacy services administrative organization or take other steps to adjust reimbursement paid to pharmacy or pharmacy services administrative organization to take into account costs incurred from new taxes or fees.

Please note: HB 2462 is scheduled solely for the purpose of referring to the House Committee on Revenue without recommendation.

HB 2965

HB 2910 **

**Subsequent Referral(s) to Ways and Means

Requires Oregon Health Authority, upon receipt of federal approval, to assess fee on emergency medical services providers and use fee to reimburse costs of emergency medical services transports.

HB 2261

Prohibits remote sales of inhalant delivery systems.
