Directs Oregon Health Authority to adopt rules requiring infants to be screened to detect certain diseases.

Requires birthing facility to perform test for detection of spinal muscular atrophy on newborn delivered at facility.

HB 2541

Provides that licensed optometrist may perform specified ophthalmic surgery procedures.

HB 2076 **

**Subsequent Referral(s) to Ways and Means

Establishes Emergency Health Care Systems Program and Emergency Health Care System Advisory Board within Oregon Health Authority.

HB 2510

Requires owner or possessor of firearm to secure firearm with trigger or cable lock, in locked container or in gun room except in specified circumstances.

HB 2591 **

**Subsequent Referral(s) to Ways and Means

Allows mobile school-based health centers to qualify for safety net grants from Oregon Health Authority.

HB 2464

Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program.

HB 2623

Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.

HB 2958

Allows pharmacist to prescribe and dispense preexposure prophylactic antiretroviral drug to patient after completion of patient assessment.

HB 2376

Requires health care provider who prescribes opioid to offer prescription for naloxone, or similar drug, and educational material under specified circumstances.
