Public Hearing

HB 2987

Directs Oregon Health Authority to adopt rules requiring infants to be screened to detect certain diseases.

Work Session

HB 2541

Provides that licensed optometrist may perform specified ophthalmic surgery procedures.

HB 2076 **

**Subsequent Referral(s) to Ways and Means

Establishes Emergency Health Care Systems Program and Emergency Health Care System Advisory Board within Oregon Health Authority.

HB 2510

Requires owner or possessor of firearm to secure firearm with trigger or cable lock, in locked container or in gun room except in specified circumstances.

HB 2362

Requires health care entities to obtain approval from Oregon Health Authority before any mergers, acquisitions or affiliations of entities that had \$25 million or more in net patient revenue in preceding three fiscal years or before mergers, acquisitions or affiliations that will result in one entity having increase in net patient revenue of \$1 million or more.

HB 2622

Requires hospitals and ambulatory surgical centers to use smoke evacuation system during surgical procedures likely to generate surgical smoke.

HB 3036

Removes requirement that physician assistant practice under supervising physician.

HB 2359

Requires health care providers to work with health care interpreters from health care interpreter registry operated by Oregon Health Authority to provide interpretation services.

HB 2462

Requires pharmacy benefit manager to amend contract with pharmacy or pharmacy services administrative organization or take other steps to adjust reimbursement paid to pharmacy or pharmacy services administrative organization to take into account costs incurred from new taxes or fees.

HB 2528

Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.

Public Hearing

HB 3107

Requires birthing facility to perform test for detection of spinal muscular atrophy on newborn delivered at facility.

HB 2623

CARRIED OVER FROM THE 3-25-2021 MEETING: Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.

HB 2958

CARRIED OVER FROM THE 3-25-2021 MEETING: Allows pharmacist to prescribe and dispense preexposure prophylactic antiretroviral drug to patient after completion of patient assessment.

HB 2376

CARRIED OVER FROM THE 3-25-2021 MEETING: Requires health care provider who prescribes opioid to offer prescription for naloxone, or similar drug, and educational material under specified circumstances.
