HB 2106 **

(3:35 PM) Provides that notice of garnishment related to overpayment of public benefits issued by Department of Human Services or Oregon Health Authority need not be signed by person issuing notice on behalf of department or authority.

HB 2394

(3:50 PM) Requires long term care facilities, residential facilities, adult foster homes and facilities with memory care endorsements to have isolation prevention plans to enable residents to communicate with other residents, family members, friends or other external support systems during public emergency.

HB 2738 **

(4:15 PM) Appropriates moneys to Court Appointed Special Advocate Fund for CASA Volunteer Program and for distribution to Oregon CASA Network for court appointed special advocate training programs.

Oral Testimony (Live Remotely)
