HB 2738 \*\*

(3:20 PM) Appropriates moneys to Court Appointed Special Advocate Fund for CASA Volunteer Program and for distribution to Oregon CASA Network for court appointed special advocate training programs.

HB 2387

Modifies CASA Volunteer Programs to direct Oregon Department of Administrative Services to contract with nongovernmental entity to serve as statewide coordinating entity for provision of court appointed special advocate services.

HB 2440 \*\* \*\*Subsequent Referral(s) to Revenue

Extends sunset for tax credit for working family dependent care.

HB 2442 \*\* \*\*Subsequent Referral(s) to Revenue

Extends sunset for additional personal exemption credit for taxpayer with severe disability.

HB 2444 \*\* \*\*Subsequent Referral(s) to Revenue

Extends sunset for tax credit for child with disability.

HB 2454 \*\* \*\*Subsequent Referral(s) to Revenue

Extends sunset of homestead property tax deferral program for certain seniors and persons with disabilities.

HB 2721 \*\* \*\*Subsequent Referral(s) to Revenue

Allows dependent care income tax credit to be claimed for expenses to allow taxpayer or spouse to attend school as enrolled degree-seeking student.

HB 2551 \*\*

\*\*Subsequent Referral(s) to Revenue then to Ways and Means

Establishes Individual Development Account Fund.
