Public Hearing

SB 86 A

(3:20 PM) Authorizes licensing agency to revoke, suspend, impose conditions on or refuse to renew license to operate residential training facility or residential training home under specified conditions and to consider performance and experience of applicant or licensee in other states or jurisdictions.

SB 89

(3:40 PM) Modifies definition of "developmental disabilities residential facility."

SB 90 A

(4:00 PM) Exempts from public disclosure addresses of individuals with intellectual or developmental disabilities residing in adult foster homes, residential training facilities or residential training homes, unless public interest requires disclosure in particular instance.

SB 97 A

(4:20 PM) Prohibits Residential Facilities Ombudsman, designee of ombudsman or staff of ombudsman from being compelled to testify or produce documents related to complaint in any judicial or administrative proceeding.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
