HB 2942 **

**Subsequent Referral(s) to Education

(1:10 pm) Removes certain nonviolent crimes from list of crimes that automatically make person ineligible to hold license or registration issued by Teacher Standards and Practices Commission if person has been convicted of crime.

Work Session

HB 2199

Requires local correctional facility to contact primary health care provider of pretrial detainee within 72 hours of booking and ensure that detainee receives health care prescribed by provider.

February 11, 2021

HB 2201

Requires local correctional facility to provide to veteran who is in pretrial detention health care recommended by United States Department of Veterans Affairs Veterans Health Administration.

Note change: HB 2823 and HB 2825 have been removed.
