HB 2586

(1:00 - 1:30 pm) Creates process for obtaining restraining order against person who is not family or household member for actions that cause bodily injury or fear of imminent bodily injury.

HB 2746

(1:30 - 1:55 pm) Directs State Court Administrator to develop and implement Hope Card Program for issuance of information cards to persons who are protected by restraining orders.

HB 2747

(1:55 - 2:25 pm) Modifies start date for calculating one-year duration of certain protective orders if court continues or modifies order more than 30 days after original order date.
