Public Hearing

HB 3265

(1:05 - 1:25 pm) Requires that officer of law enforcement agency who arrests individual who is foreign national inform individual of consular notification procedures.

HB 3174

(1:25 - 1:45 pm) Prohibits court from allowing public display or public disclosure of images of person in state of nudity, except pursuant to court order entered after showing of good cause.

HB 2400

(1:45 - 1:55 pm) Provides that victim of sexual assault or domestic violence crime has right to obtain law enforcement records relating to crime.

HB 2418

(1:55 - 2:05 pm) Requires district attorney to, upon request, provide to sexual assault victim opportunity to review case file within district attorney's office.

Work Session

HB 2513

Requires police officers to be trained in airway and circulatory anatomy and physiology and certified in cardiopulmonary resuscitation.

HB 2746

Directs State Court Administer to develop and implement Hope Card Program for issuance of information cards to persons who are protected by restraining orders.

HB 2939

Declares venue of juvenile proceeding subject to waiver hearing to be county where alleged act was committed.

HB 2940

Creates exception to 28-day time limit for detention of youth if request for waiver hearing is pending.

HB 3035

Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.

HB 3115

CARRIED OVER FROM THE 3/23/21 AGENDA: Provides that local law regulating sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.

HB 3164

Modifies crime of interfering with a peace officer or parole and probation officer.

Please note: The following bills are scheduled solely for the purpose of committee discussion:

HB 2459

Includes in definition of "conversation" communication occurring through video conferencing program for purposes of statutes regulating recording of communications.

HB 2547

Directs State Court Administrator to study methods for assigning single judge to domestic relations cases to serve throughout duration of case.

HB 2571

Directs Department of Consumer and Business Services, in consultation with State Forestry Department, Oregon State University and Oregon Prescribed Fire Council, to study liability for prescribed fires.

HB 2930

Imposes limitations on arbitrators' decisions concerning alleged misconduct by law enforcement officers.

HB 2932

Directs Oregon Criminal Justice Commission to establish statewide database of reports of use of physical force by peace officers and corrections officers.

HB 2936

Requires Department of Public Safety Standards and Training to investigate person's character before accepting person for training and certification as police officer or reserve officer.

HB 3047

Establishes civil cause of action for improper disclosure of personal information.

HB 3273

Prohibits law enforcement agency from releasing booking photo except in specified circumstances.
