Work Session

HB 2036

Authorizes State Board of Parole and Post-Prison Supervision to discharge person from parole or post-prison supervision prior to end of supervision term for specified medical reason if compatible with best interests of person and community.

HB 2502 **

**Subsequent Referral(s) to Ways and Means

Adds five members to Task Force on School Safety.

HB 2527

Requires Department of Public Safety Standards and Training to establish by rule standards and procedures for licensing of private security entities.

HB 3035

CARRIED OVER FROM THE 3/30/21 AGENDA: Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.

Recommended from the House Judiciary Subcommittee on Civil Law:

HB 2547

CARRIED OVER FROM THE 3/30/21 AGENDA: Directs State Court Administrator to study methods for assigning single judge to domestic relations cases to serve throughout duration of case.

HB 2459

CARRIED OVER FROM THE 3/30/21 AGENDA: Includes in definition of "conversation" communication occurring through video conferencing program for purposes of statutes regulating recording of communications.

HB 2935

CARRIED OVER FROM THE 3/30/21 AGENDA: Limits authority of school district to become member of voluntary organization that administers interscholastic activities unless organization implements policy that prohibits discrimination based on race, color or national origin.

HB 3041

CARRIED OVER FROM THE 3/30/21 AGENDA: Removes "gender identity" from definition of "sexual orientation" in ORS 174.100 and creates standalone definition of "gender identity" in ORS 174.100.

HB 3284

Prohibits covered organization from collecting, using or disclosing personal data about resident individual who has not given affirmative express consent for collection, use or disclosure unless in context of employment relationship or to comply with legal obligation.

Recommended from the House Judiciary Subcommittee on Equitable Policing:

HB 2513

CARRIED OVER FROM THE 3/30/21 AGENDA: Requires police officers to be trained in airway and circulatory anatomy and physiology and certified in cardiopulmonary resuscitation.

HB 2930

Imposes limitations on arbitrators' decisions concerning alleged misconduct by law enforcement officers.

HB 3355

Specifies identification required on uniforms of law enforcement officers working in crowd management.

Please note: The following bills are scheduled solely for the purpose of committee discussion:

HB 2482

Removes entering or remaining unlawfully in or on public transit vehicle or public transit station as manner of committing crime of interfering with public transportation.

HB 3176

Permits chief administrative law judge to require implied consent hearing to be conducted by telephone or other two-way communication device if judge determines that meeting in person poses significant risk to health or safety.

Recommended from the House Judiciary Subcommittee on Civil Law:

AGENDA (cont.) April 1, 2021

- HB 2177 ** **Subsequent Referral(s) to Ways and Means
Authorizes Chief Justice of Supreme Court to collect fees from certain public bodies for use of certain state court technology services.
- HB 2204
Provides that public safety officer who represents that person is acting as employee or agent of public body is acting in scope of employment for purposes of Oregon Tort Claims Act.
- HB 2523
Directs Department of Transportation to waive driving privilege reinstatement fee if driving privileges were suspended for failing to pay fine.
- HB 2571
Directs Department of Consumer and Business Services, in consultation with State Forestry Department, Oregon State University and Oregon Prescribed Fire Council, to study liability for prescribed fires.

Recommended from the House Judiciary Subcommittee on Equitable Policing:

- HB 3145 ** **Subsequent Referral(s) to Ways and Means
Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

Public Hearing

- HB 3229 ** **Subsequent Referral(s) to Ways and Means
(2:30 - 2:45 pm) Directs Oregon Criminal Justice Commission to convene advisory council to assist with recommendations related to health care standards in local correctional facilities.

Note change: Work sessions added on HB 3035, HB 2935, HB 2459, HB 2547, HB 2571, HB 3041, and HB 2513.

April 1, 2021

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
