HB 3298

(1:05 - 1:20 pm) Modifies procedures for early medical release of adult in custody from prison.

HB 3229 \*\*

\*\*Subsequent Referral(s) to Ways and Means

(1.20 1.25 nm) Directs One and Criminal Institute Commission to a support Assignment States

(1:20 - 1:35 pm) Directs Oregon Criminal Justice Commission to convene advisory council to assist with recommendations related to health care standards in local correctional facilities.

HB 3266

(1:35 - 1:50 pm) Directs Department of Corrections to ensure specified health services are provided to adults in custody during pregnancy, labor, birth and postpartum period.

HB 3359

(1:50 - 2:05 pm) Establishes Task Force on Digital Rights.

#### **Work Session**

HB 2036

Authorizes State Board of Parole and Post-Prison Supervision to discharge person from parole or post-prison supervision prior to end of supervision term for specified medical reason if compatible with best interests of person and community.

HB 2502 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Adds five members to Task Force on School Safety.

HB 2527

Requires Department of Public Safety Standards and Training to establish by rule standards and procedures for licensing of private security entities.

HB 2928

Regulates use of chemical incapacitants, kinetic impact projectiles and sound devices by law enforcement agencies.

HB 2930

Imposes limitations on arbitrators' decisions concerning alleged misconduct by law enforcement officers.

HB 3059

Repeals statute authorizing law enforcement officers to command dispersal of unlawful assemblies and arrest participants who do not disperse.

HB 3355

Specifies identification required on uniforms of law enforcement officers working in crowd management.

HB 2547

Directs State Court Administrator to study methods for assigning single judge to domestic relations cases to serve throughout duration of case.

# Please note: The following bills are scheduled solely for the purpose of committee discussion:

HB 2482

Removes entering or remaining unlawfully in or on public transit vehicle or public transit station as manner of committing crime of interfering with public transportation.

HB 2523

Directs Department of Transportation to waive driving privilege reinstatement fee if driving privileges were suspended for failing to pay fine.

HB 3145 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

HB 3176

Permits chief administrative law judge to require implied consent hearing to be conducted by telephone or other two-way communication device if judge determines that meeting in person poses significant risk to health or safety.

HB 2177 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Authorizes Chief Justice of Supreme Court to collect fees from certain public bodies for use of certain state court technology services.

# AGENDA (cont.) April 1, 2021

#### HB 3284

Prohibits covered organization from collecting, using or disclosing personal data about resident individual who has not given affirmative express consent for collection, use or disclosure unless in context of employment relationship or to comply with legal obligation.

#### HB 2204

Provides that public safety officer who represents that person is acting as employee or agent of public body is acting in scope of employment for purposes of Oregon Tort Claims Act.

Note change: Added public hearings on HB 3298, HB 3229, HB 3266, and HB 3359. Added work sessions on HB 2547, HB 2177, HB 3284, and HB 2204.
