Public Hearing

HB 3274

(1:05 - 1:20 pm) Directs Department of Corrections to develop strengths-based release planning assessment.

HB 3285

(1:20 - 1:35 pm) Modifies definition of "abuse" for purposes of Elderly Persons and Persons With Disabilities Abuse Prevention Act to include certain telephone solicitation.

HB 3186

(1:35 pm - 1:45 pm) Describes coercive control.

HB 3005

(1:45 - 2:05 pm) Repeals statute creating state preemption of local firearm regulation and statutes creating exceptions to preemption.

HB 3216

(2:05 - 2:15 pm) Directs Oregon Criminal Justice Commission to conduct study on persons released from local correctional facilities due to circumstances caused by COVID-19 and to provide results of study to interim committees of Legislative Assembly no later than May 31, 2022.

Work Session

HB 2002

Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences.

HB 2003

Expands membership of Public Defense Services Commission from seven to nine members.

HB 2169

Directs Racial Justice Council to study potential changes to criminal justice system and to provide results of study to Legislative Assembly no later than December 31, 2021.

HB 2482

Removes entering or remaining unlawfully in or on public transit vehicle or public transit station as manner of committing crime of interfering with public transportation.

HB 2523

Directs Department of Transportation to waive driving privilege reinstatement fee if driving privileges were suspended for failing to pay fine.

HB 2575

Directs Department of Justice to establish program for awarding grants to law enforcement agencies and local governments for training of groups and agencies that interact with persons who have experienced trauma.

HB 3164

Modifies crime of interfering with a peace officer or parole and probation officer.

HB 3176

Permits chief administrative law judge to require implied consent hearing to be conducted by telephone or other two-way communication device if judge determines that meeting in person poses significant risk to health or safety.

HB 3182

Directs Department of Human Services to study and make recommendations on provisions of state law relating to adoption of Indian children.

HB 3298

Modifies procedures for early medical release of adult in custody from prison.

HB 3230 **

**Subsequent Referral(s) to Ways and Means

Establishes universal representation program in Oregon Department of Administrative Services.

HB 2399

Permits employers to seek issuance of restraining order or stalking protective order on behalf of employee when certain conditions are met.
