#### Public Hearing

HB 2172

(1:05 - 1:30 pm) Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences.

HJM 7

(1:30 pm - 1:45 pm) Urges Congress to pass legislation to allow access to specified federal health benefits and programs for pretrial detainees, by redefining term "inmates of a public institution" as used in federal Social Security Act.

HB 3327 \*\*

\*\*Subsequent Referral(s) to Ways and Means

(1:45 - 2:00 pm) Extends sunset for authorization to Department of Justice to assist victims of domestic violence and sexual assault with housing needs until January 2, 2024.

HB 2047

Modifies authority of Department of Corrections to receive, hold and dispose of property.

HB 2048

Requires court to send to Department of Corrections certified copy of order setting aside conviction.

HB 2936

Requires Department of Public Safety Standards and Training to investigate person's character before accepting person for training and certification as police officer or reserve officer.

HB 3096

Directs Department of Corrections to study issues specific to women in custody of department and to provide results of study to Legislative Assembly no later than December 31, 2021.

HB 3112 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Cannabis Equity Board within office of Governor to provide equity oversight of cannabis industry in this state.

HB 3145 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

HJR 5

Proposes amendment to Oregon Constitution to repeal provision requiring inmates in corrections institutions to engage in full-time work or on-the-job training.

HB 3186

Describes coercive control.

HB 3265

Requires that officer of law enforcement agency who arrests individual who is foreign national inform individual of consular notification procedures.

HB 3285

Modifies definition of "abuse" for purposes of Elderly Persons and Persons With Disabilities Abuse Prevention Act to include certain telephone solicitation.

HB 3274

Directs Department of Corrections to develop strengths-based release planning assessment.

HB 3266

Directs Department of Corrections to ensure specified health services are provided to adults in custody during pregnancy, labor, birth and postpartum period.

HB 3229 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Oregon Criminal Justice Commission to convene advisory council to assist with recommendations related to health care standards in local correctional facilities.

HB 3174

Prohibits court from allowing public display or public disclosure of images of person in state of nudity, except pursuant to court order entered after showing of good cause.

HB 3359

Establishes Task Force on Digital Rights.

HB 2177 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Authorizes Chief Justice of Supreme Court to collect fees from certain public bodies for use of certain state court technology services.

## **AGENDA (cont.)**

### **April 8, 2021**

HB 3284

Prohibits covered organization from collecting, using or disclosing personal data about resident individual who has not given affirmative express consent for collection, use or disclosure unless in context of employment relationship or to comply with legal obligation.

HB 2204

Provides that public safety officer who represents that person is acting as employee or agent of public body is acting in scope of employment for purposes of Oregon Tort Claims Act.

HB 3216

Directs Oregon Criminal Justice Commission to conduct study on persons released from local correctional facilities due to circumstances caused by COVID-19 and to provide results of study to interim committees of Legislative Assembly no later than May 31, 2022.

***Note change: Public hearing added for HR 3327. Work session added for HB 3216.***
