Work Session

SB 186

Approves modifications to rules of Oregon Criminal Justice Commission.

Please note: SB 186 is scheduled for purpose of committee discussion and possible work session.

SB 188 A

Clarifies that state felony traffic offenses charged in Multnomah County will be heard in court facility in Portland.

Please note: SB 188 A is scheduled for purpose of committee discussion and possible work session.

SB 296 A

Authorizes Chief Justice of Supreme Court, during period of statewide emergency and upon finding of good cause, to extend or suspend time period or time requirement in rule or statute in specified court proceedings.

Please note: SB 296 A scheduled for purpose of committee discussion and possible work session.

SB 297

Provides that judicial marshal certified by Department of Public Safety Standards and Training qualifies as police officer under Public Employees Retirement System.

Please note: SB 297 scheduled for purpose of committee discussion and possible work session.

SB 704

Provides that discovery of victim's actual or perceived gender, gender identity, gender expression or sexual orientation does not constitute reasonable explanation for extreme emotional disturbance for purposes of affirmative defense to murder in the second degree.

Please note: SB 704 scheduled for purpose of committee discussion and possible work session.

Public Hearing

SB 298

(1:20 - 1:30 pm) Conforms language in provisions relating to stalking protective order to language used in other provisions relating to protective orders.

SJM 2

(1:30 - 2:25 pm) Urges Congress to amend Thirteenth Amendment to United States Constitution to omit clause excepting criminal punishment, thereby ending racist legacy of slavery in nation's most important document.

SJM 4

(1:30 - 2:25 pm) Urges Congress to enact legislation to begin process of implementing reparations for African Americans based on slavery and discrimination.

SJR 10

(1:15 - 2:25 pm) Proposes amendment to Oregon Constitution to prohibit slavery and involuntary servitude in all circumstances.

SB 116 A

(2:25 - 2:45 pm) Provides that it is unlawful for private security provider or entity that employs private security providers to possess or use equipment, vehicles, uniforms or titles that imply affiliation with public or private safety agency.

Note Change: Public Hearing times adjusted. Public Hearing on SB 116 A added. SB 704 Work Session added. Possible Work Sessions added to SB 186, SB 188 A, SB 296 A, SB 297, and SB 704.

- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
