#### Work Session

SB 565 A

Modifies definition of "slayer" to include individuals who are found responsible or guilty except for insanity of taking person's life.

SB 186

Approves modifications to rules of Oregon Criminal Justice Commission.

SB 188 A

Clarifies that state felony traffic offenses charged in Multnomah County will be heard in court facility in Portland.

SB 296 A

Authorizes Chief Justice of Supreme Court, during period of statewide emergency and upon finding of good cause, to extend or suspend time period or time requirement in rule or statute in specified court proceedings.

SB 297

Provides that judicial marshal certified by Department of Public Safety Standards and Training qualifies as police officer under Public Employees Retirement System.

SB 704

Provides that discovery of victim's actual or perceived gender, gender identity, gender expression or sexual orientation does not constitute reasonable explanation for extreme emotional disturbance for purposes of affirmative defense to murder in the second degree.

### Public Hearing

SB 298

(1:20 - 1:30 pm) Conforms language in provisions relating to stalking protective order to language used in other provisions relating to protective orders.

SJM 2

(1:30 - 2:25 pm) Urges Congress to amend Thirteenth Amendment to United States Constitution to omit clause excepting criminal punishment, thereby ending racist legacy of slavery in nation's most important document.

SJM 4

(1:30 - 2:25 pm) Urges Congress to enact legislation to begin process of implementing reparations for African Americans based on slavery and discrimination.

SJR 10

(1:15 - 2:25 pm) Proposes amendment to Oregon Constitution to prohibit slavery and involuntary servitude in all circumstances.

SB 116 A

(2:25 - 2:45 pm) Provides that it is unlawful for private security provider or entity that employs private security providers to possess or use equipment, vehicles, uniforms or titles that imply affiliation with public or private safety agency.

- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

*Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.*
