SB 190 A

(3:35 - 3:50 pm) Modifies permissible methods of providing notice of appointment of guardian to protected person.

SB 578 A

(3:50 - 4:10 pm) Requires court, under certain circumstances, to appoint legal counsel for respondent or protected person in protective proceeding.

SB 572

(4:10 - 4:35 pm) Modifies protective proceedings to permit vulnerable youth guardianships for adults between 18 and 21 years of age who are eligible for special immigrant status and who are unable to be reunified with parent due to abuse, neglect or abandonment that occurred before adult attained 18 years of age.

Work Session

SB 765

Makes permanent provisions allowing notary public to perform notarial act using communication technology for remotely located individual under certain circumstances.

SB 220

Prescribes formalities for remote attestation of writing.

SB 221

Modifies court procedure for determining whether decedent intended writing to be decedent's will, partial or complete revocation of decedent's will or addition to or alteration of decedent's will.

SB 728

Modifies provisions of law relating to administration of decedents' estates.
