SB 753

(3:35 - 3:50 pm) Repeals requirement that Division of Child Support provide certain spousal support enforcement services for obligees who receive public assistance but who are not also receiving child support enforcement services.

SB 822

(3:50 - 4:10 pm) Consolidates unpaid child support accruing under superseded child support order into amounts payable under later-issued court order.

SB 190 A

Modifies permissible methods of providing notice of appointment of guardian to protected person.

SB 578 A
