Public Hearing

HB 3145

(8:05 - 8:50 am) Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

HB 2930

(8:50 - 9:30 am) Imposes limitations on arbitrators' decisions concerning alleged misconduct by law enforcement officers.

HB 2513

(9:30 am, if needed) Requires police officers to be trained in airway and circulatory anatomy and physiology and certified in cardiopulmonary resuscitation.
