HB 2986

(8:30 - 8:50 am) Requires Board on Public Safety Standards and Training to ensure that police officers and certified reserve officers are trained to investigate, identify and report crimes motivated by prejudice based on perceived gender of victim.

HB 3047

(8:50 - 9:20 am) Establishes civil cause of action for improper disclosure of personal information.

#### Work Session

HB 2481

Prohibits law enforcement agencies from receiving certain military surplus equipment from federal government.

HB 2932

Directs Oregon Criminal Justice Commission to establish statewide database of reports of use of physical force by peace officers and corrections officers.

HB 3145

Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.
