Public Hearing

HB 3355

(8:05 - 8:40 am) Specifies identification required on uniforms of law enforcement officers working in crowd management.

Work Session

HB 2513

CARRIED OVER FROM THE 3/8/2021 MEETING: Requires police officers to be trained in airway and circulatory anatomy and physiology and certified in cardiopulmonary resuscitation.

March 10, 2021

HB 2575

CARRIED OVER FROM THE 3/8/2021 MEETING: Directs Department of Justice to establish program for awarding grants to law enforcement agencies and local governments for training of groups and agencies that interact with persons who have experienced trauma.

HB 2932

CARRIED OVER FROM THE 3/8/2021 MEETING: Directs Oregon Criminal Justice Commission to establish statewide database of reports of use of physical force by peace officers and corrections officers.

HB 2986

CARRIED OVER FROM THE 3/8/2021 MEETING: Requires Board on Public Safety Standards and Training to ensure that police officers and certified reserve officers are trained to investigate, identify and report crimes motivated by prejudice based on perceived gender of victim.

HB 3145

CARRIED OVER FROM THE 3/8/2021 MEETING: Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

HB 3164

CARRIED OVER FROM THE 3/8/2021 MEETING: Modifies crime of interfering with a peace officer or parole and probation officer.

HB 3047

Establishes civil cause of action for improper disclosure of personal information.

HB 2936

Requires Department of Public Safety Standards and Training to investigate person's character before accepting person for training and certification as police officer or reserve officer.

HB 3273

Prohibits law enforcement agency from releasing booking photo except in specified circumstances.

HB 2928

Regulates use of chemical incapacitants, kinetic impact projectiles and sound devices by law enforcement agencies.

March 10, 2021
