Public Hearing

HB 2128

Requires tax professional to report breach of security associated with tax return preparation to Department of Revenue.

HB 2129

Updates statutes governing contributions of personal income tax refunds by checkoff.

HB 2130

Extends, to conform with income tax return due date frequently delayed if due date falls on weekend or based on observation of Emancipation Day holiday in District of Columbia, date for filing declaration of estimated tax and making estimated tax installment payment.

HB 2131

Provides for liability of officer, employee or member of entity for unpaid amounts of taxes or fees collected by entity and held in trust for payment to Department of Revenue.
