Property Tax Central Assessment and Industrial Appraisal

Public Hearing

HB 2331

Excludes over-the-air broadcasting from meaning of "communication" for purposes of central assessment for property taxation.

HB 2634

Allows surviving spouse or disabled heir of individual whose homestead was granted deferral under homestead property tax deferral program to continue deferral without having owned or occupied homestead for five years.

HB 2693

Allows exception to requirement for property tax exemption that property of industry apprenticeship or training trust be actually and exclusively occupied and used for purposes of industry apprenticeship or training trust for occasional use by corporation exempt from federal income tax for purposes for which corporation is granted federal exemption.
