HJR 11

(1:05 pm) CARRIED OVER FROM THE 2/11/2021 AGENDA: Proposes amendment to Oregon Constitution providing for same-day voter registration.

HB 2485

(1:45 pm) Requires state agencies to reduce public records request fees by 50 percent if request is made in public interest, and requires state agencies to entirely waive fees if public records request is in public interest and narrowly tailored.

HB 2487

(2:15 pm) Modifies provisions relating to public records about public safety officers.
