HB 2485

(1:05 pm) Requires state agencies to reduce public records request fees by 50 percent if request is made in public interest, and requires state agencies to entirely waive fees if public records request is in public interest and narrowly tailored.

HB 2487

(1:35 pm) Modifies provisions relating to public records about public safety officers.

HB 2486

(2:05 pm) Requires, on or after October 1, 2021, officials of public bodies to grant news media representatives access to scenes of emergencies or emergency police activity that are otherwise closed to public.
