Public Hearing

HB 2353

(1:05 pm) Requires agency to include in rulemaking notice statement identifying how adoption of rule will affect racial equity.

HB 2991

(1:35 pm) Requires Legislative Policy and Research Director or chief sponsor of bill or proposed constitutional amendment to prepare racial and ethnic impact statement.

HB 2993

(2:05 pm) Requires agency to appoint advisory committee to represent interests of persons likely to be affected by proposed rule.

Written testimony should be submitted via the Oregon Legislative Information System (OLIS) testimony portal. Testimony must be received within 24 hours after the start time of the meeting in which the public hearing is held. Testimony is uploaded to OLIS as part of the legislative record and
