HB 2605

(1:05 pm) Imposes tsunami design standards for certain buildings and other structures.

HB 2644

(1:35 pm) Renames portion of Interstate 5, beginning in Albany and ending in Salem, to Atomic Veterans and Atomic Cleanup Veterans Memorial Highway.

HJM 2

(1:35 pm) Urges Congress to enact law to provide for treatment of veterans who participated in cleanup of Enewetak Atoll as radiation-exposed veterans for certain purposes.

HB 2526

(2:05 pm) Designates second Monday of October of each year as Indigenous Peoples' Day.

HB 2485

(2:35 pm) Requires state agencies to reduce public records request fees by 50 percent if request is made in public interest, and requires state agencies to entirely waive fees if public records request is in public interest and narrowly tailored.

HB 2560

(2:35 pm) Requires governing body of public body, to extent reasonably possible, to make all meetings accessible remotely through technological means and provide opportunity for members of general public to remotely submit oral and written testimony during meetings to extent inperson oral and written testimony is allowed.
