## Public Hearing

HB 3291

CARRIED OVER FROM THE 4-6-2021 AGENDA: (1:05 pm) Requires Secretary of State to conduct study and analyze best practices for financing electoral campaigns.

Please note: HB 3291 is scheduled for the purpose of hearing the -1 amendment.

## Work Session

HB 2993

CARRIED OVER FROM THE 4-6-2021 AGENDA: Requires agency to appoint advisory committee to represent interests of persons likely to be affected by proposed rule. HB 3110

CARRIED OVER FROM THE 4-6-2021 AGENDA: Requires board of directors of publicly traded corporation to have specified proportion of female directors and directors who are members of underrepresented communities.

# AGENDA (cont.) April 8, 2021

#### HB 2991

Requires Legislative Policy and Research Director or chief sponsor of bill or proposed constitutional amendment to prepare racial and ethnic impact statement.

HB 3389

Extends look-back period used to determine Unemployment Compensation Trust Fund solvency level from 10 years to 20 years.

### **Public Hearing**

HB 2524

(1:45 pm) Places limits on certain restrictions by local governments, planned communities and condominiums on use of property for child care facilities.

HB 2944

(2:10 pm) Requires Legislative Assembly to provide translator and interpreter services free of charge in order to facilitate witness participation in hearings or informal meetings with one or more members of Legislative Assembly, as required by federal Americans with Disabilities Act, or in conjunction with constituent outreach services.

HB 3264 \*\* \*\*Subsequent Referral(s) to Ways and Means
 (2:10 pm) Requires Legislative Assembly to provide translator and interpreter services free of charge in order to facilitate witness participation in hearings or informal meetings with one or more members of Legislative Assembly, as required by federal Americans with Disabilities Act, or in conjunction with constituent outreach services.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
