#### **Public Hearing and Possible Work Session**

HB 3021  
(1:05 pm) Requires Secretary of State to create and make publicly available list of five most common languages spoken by residents of state.

HB 2745  
(1:25 pm) Requires voter registration cards and electronic voter registration system to include option for person to identify race, ethnicity and preferred language of person.

HB 2167  
(1:45 pm) Directs Office of Governor to study and make recommendations regarding certain proposals relating to state boards and commissions.

#### **Work Session**

HB 2526  
Designates second Monday of October of each year as Indigenous Peoples' Day.

## AGENDA (cont.)

HB 2064

Modifies quorum requirement for Energy Facility Siting Council.

HB 2323

Prohibits knowingly communicating materially false statement with intent to mislead electors about date of election, deadline for delivering ballot, voter registration deadline, method of registering to vote, locations at which elector may deposit ballot, qualifications of electors or voter registration status within 30 days of primary election or special election or within 60 days of general election.

HB 2991

CARRIED OVER FROM THE 4-8-2021 AGENDA: Requires Legislative Policy and Research Director or chief sponsor of bill or proposed constitutional amendment to prepare racial and ethnic impact statement.

HB 3110

CARRIED OVER FROM THE 4-8-2021 AGENDA: Requires board of directors of publicly traded corporation to have specified proportion of female directors and directors who are members of underrepresented communities.
