Work Session

HB 2001

Requires school district that is making reductions in educator staff positions to retain teacher with less seniority if teacher has more merit and if retention of teacher is necessary to maintain school district's diversity ratio.

HB 2166

CARRIED OVER FROM THE 5-20-2021 AGENDA: Directs Superintendent of Public Instruction to convene advisory group to review equity in education system of state and to report results of review to interim committee of Legislative Assembly related to education.

HB 2337

CARRIED OVER FROM THE 5-20-2021 AGENDA: Requires state agencies and third party contractors that collect demographic data on behalf of state agencies to comply with rules adopted by Oregon Health Authority for collection of data on race, ethnicity, preferred spoken and written languages and disability status.

HB 3000 A

Defines "adult use cannabis item," "artificially derived cannabinoid" and "tetrahydrocannabinol" for statutes related to marijuana and industrial hemp.

HB 2281 A**

**Subsequent Referral(s) to Ways and Means

Directs State Department of Agriculture to administer Oregon Hemp State Program for production, processing and sale of hemp.

HB 2026 A

(4:45 pm) Requires public employers to give preferences to residents of Eastern Oregon Border Economic Development Region for civil service positions if majority of work of position will be performed within region.

Note change: SB 483, SCR 16, and SCR 20 have been removed.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
