SB 806 A

Includes "fortified cider" in definition of "cider." Allows holder of winery license to purchase from Oregon Liquor Control Commission distilled liquors for fortifying cider.

SB 866

Permits municipality or Department of Consumer and Business Services to contract with person to administer and enforce building inspection program and act as building official.

SB 857 A

(1:25 pm) Provides that maximum loading weight of motorboat must be less than 5,000 pounds to obtain towed watersports motorboat certificate.
