(4:15 pm) Establishes Task Force on Rural Fire Protection District Community Development to study and develop recommendations for developing, enhancing or expanding ability of rural fire protection districts to facilitate community development efforts following natural disaster.

HB 2295 \*\* \*\*Subsequent Referral(s) to Revenue

(4:35 pm) Provides that fire chief, or representative of fire chief, of county may extinguish uncontrolled fire found to be burning in unprotected area.
