#### **Public Hearing and Possible Work Session**

HB 3126

(10:25 AM) Directs Legislative Policy and Research Office to study strategies to promote recovery from 2020 wildfire season and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

HB 3367

(10:35 AM) Requires local governments to unconditionally allow restoration or replacement of certain uses destroyed by 2020 wildfires until December 31, 2025.

HB 3315

(10:40 AM) Directs Housing and Community Services Department to study issues relating to building in areas affected by wildfires and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

HB 2272

(10:45 AM) Directs Department of Land Conservation and Development to study issues relating to use of land and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

*Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.*

**Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.**
