Work Session

- HB 2018
(8:00 am) Instructs Water Resources Department to enter into agreement with United States Geological Survey to produce and publish ground water budgets for all major hydrologic basins in this state, contract for person to produce report on statewide consumptive water use, establish ground water level monitoring network and measure progress in estimating and monitoring ground water levels and ground water use.
- HB 3242 ** **Subsequent Referral(s) to Ways and Means
(8:10 am) Directs Water Resources Department to undertake certain activities related to studying and monitoring ground water.
- HB 2142 ** **Subsequent Referral(s) to Ways and Means
(8:20 am) Increases certain fees charged by Water Resources Department.
- HB 2145 ** **Subsequent Referral(s) to Ways and Means
(8:30 am) Limits time for Water Resources Commission to enforce standards related to wells against well constructor.

- HB 3105 ** **Subsequent Referral(s) to Ways and Means
(8:40 am) Appropriates moneys to Water Resources Department to assist with completion of place-based integrated water resources strategy, to periodically update place-based integrated water resources strategy to inform updates to state integrated water resources strategy or to facilitate implementation of place-based integrated water resources strategy.
- HB 3092 ** **Subsequent Referral(s) to Ways and Means
(8:50 am) Requires Water Resources Department to establish grant program for purpose of sharing cost of remediating reductions in amount of ground water available for domestic personal use in Greater Harney Valley Groundwater Area of Concern due to overallocation of ground water for agricultural use.
- HB 2257 ** **Subsequent Referral(s) to Ways and Means
(9:00 am) Appropriates moneys to Water Resources Department for purposes of facilitating enrollment of lands in Harney Basin in federal Conservation Reserve Program, funding hydrologist position and measuring ground water levels in Harney Basin.

Public Hearing and Work Session

- HB 3101 ** **Subsequent Referral(s) to Ways and Means
(9:10 am) Directs Water Resources Department to establish grant program for purposes of providing grants for abandonment, repair or replacement of certain water wells.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
