#### Public Hearing

HB 2052

Requires school district to allow students to wear Native American items of cultural significance at public school events, including high school graduation.

HB 2056

Expands high school diploma requirements related to completion of credits in English to allow completion of credits in language arts.

SB 240

Removes limitation on percentage of students in school district who may enroll in virtual public charter school not sponsored by school district without first receiving approval from school district.
