#### Public Hearing

SB 473

Directs Department of Revenue to identify and notify annually personal income taxpayers that are likely eligible for employment-related child care services administered by Department of Human Services.

SB 101

Modifies eligibility requirements and grant amounts for educational grants to members of Oregon National Guard.
